- 1. CONTEST PERIOD:** Contest begins at 10AM on Wednesday April 1<sup>st</sup>, 2026 and ends on Monday, May 25<sup>th</sup>, 2026 at 11:59PM . (“Contest Period”)
- 2. HOW TO ENTER:** During the Contest Period, go to the stations (HD 96.3) website, [www.hdhiphop963.com](http://www.hdhiphop963.com), and enter to win by filling out online entry form. Listeners may enter once per contest period. Entries will be accepted until 11:59:59pm on May 25<sup>th</sup>, 2026
- 3. ELIGIBILITY:** The Contest is open only to individuals who are legal residents of the United States residing in California in the Stations DMA who are 18 years of age or older at the time of entry.
